NOTICE IS HEREBY GIVEN pursuant to G.S. 163-33(8) that the Towns of Nashville and Red Oak non-partisan municipal elections shall be held on Tuesday, November 4, 2025. The Town of Nashville will be electing Town Council Members and the Town of Red Oak will be electing a Mayor and Town Commissioners. The polls shall be open on Election Day at 6:30 a.m. and will close at 7:30 p.m. The polling place for Town of Nashville is the Nash County Agriculture Center. Town of Red Oak voters will vote at their normal polling place, except for voters who live in Oak Level. Red Oak voters who live in the Oak Level precinct will vote on Election Day at the Red Oak Volunteer Fire Dept.

All residents of the towns who are registered to vote with the County Board of Elections may vote in this election. Those town residents who are not registered to vote must register by Friday, October 10, 2025, to be eligible to vote in this election. Also, any voter who has moved since the last election must notify the Board of Elections of that change by the same date. Qualified persons may register with or request an application for registration from the Board of Elections between 8:00 a.m. and 5:00 p.m. Monday through Friday. Applications for registration are also available on our website www.nash-countyboe.com.

Any qualified voter may vote an absentee ballot by mail. Applications may be submitted in person or by mail to the Nash County Board of Elections. Voters may also complete the application on the State Board of Elections website. The deadline for applying for an absentee ballot by mail is 5:00 p.m., Tuesday, October 28, 2025.

Persons wishing to register and vote after the registration deadline may appear in person at the early voting site, complete the voter registration application form and provide proof of residence by presenting valid documents showing current name and address. Early voting begins on Thursday, October 16, 2025 and ends on Saturday, November 1, 2025. Anyone who wishes to vote early may do so between 8:00 a.m. and 5:00 p.m. Monday through Friday and on Saturday from 8:00 a.m. to 3:00 p.m. at the Nash County Board of Elections Office, 1006 Eastern Avenue, Nashville.

The Board of Elections, if needed, will meet each Tuesday beginning October 14, 2025 through October 28, 2025 at 5:00 p.m. for the purpose of approving absentee ballot applications. The board will also meet at 4:00 p.m. on Monday, November 3, 2025 to approve absentee ballot applications. Absentee ballots will be counted on Election Day, November 4, 2025 at 4:00 p.m. and again at 7:30 p.m. in the Board of Elections office; results will be released after the polls close. The Board of Elections, if needed, will meet on Friday, November 7, 2025 at 2:00 p.m. for the purpose of approving and counting any remaining Absentee Ballots and Provisional Ballots. Canvass will be held at the Board of Elections Office on Friday, November 14, 2025 at 11:00 a.m.

Electioneering is not allowed within 50 feet of the entrance door to the polling place.
